THE SUSTAINABILITY OF NORTH AMERICAN HARDWOODS CAN BE SUPPORTED BY THE FOLLOWING EVIDENCE:

U.S. Facts & Findings


- Hardwood trees grown in the United States are an abundant, sustainable and legal resource.¹
- The volume of U.S. hardwoods has increased by more than 90 percent in the last half-century while forest acreage has increased by 18 percent.²
- Hardwood procured from anywhere in the hardwood states could be considered Low Risk in all five Forest Stewardship Council (FSC) controlled wood risk categories (with only minor and occasional instances contrary to this finding identified).³
- There exists a low risk that U.S. hardwoods are produced from controversial sources as defined in the Chain of Custody standard of the Program for the Endorsement of Forest Certification (PEFC).³
- U.S. hardwoods have been awarded the highest conservation crop rating available.
- The United States Senate – (1) recognizes that United States hardwoods are abundant, sustainable, and legal resource under United States law; and (2) urges that United States hardwoods be given full consideration in any program to promote construction of environmentally preferable commercial, public or private buildings.⁵

Canadian Facts & Findings

- Less than 0.2% of Canada's forests are harvested annually.⁶
- By law, all forests harvested on Canada's public land must be successfully regenerated.⁶
- As of December 2011, Canada had 150.6 million hectares of forests certified as being sustainably managed under one or more of three globally recognized certification systems.⁶
